GENERAL DESCRIPTION:

This is a flexible white opaque vinyl film coated with a removable pressure sensitive acrylic adhesive backed with a two side poly coated lay flat release liner.

## NOTE:

This product adheres well and removes easily from most surfaces. However, application environments and certain surfaces such as vinyl (PVC), varnished wood, acrylic, polycarbonate may cause increased adhesion and adhesive transfer. We recommend that all surfaces be tested for compatibility and removability.
